POLICY GUIDELINES

- A Membership Card is required for identification purposes and will be provided for each BCCC membership. *\$10 Replacement Card Fee if lost.*
- All members are required to check in the golf shop before playing. Access to the practice facility is granted by providing identification to the golf staff.
- No outside food or beverage will be allowed on the property.
- A cancellation call of 72 hours is requested for all tee times. No shows will be charged to the member at the prevailing guest fee. Tee times that are booked and not played are the responsibility of the member booking the tee time. Non compliance will result in membership suspension until paid.
- Members are responsible for themselves and their guests with regard to excessive damage caused to the facility, property or golf cart.
- BCCC requires appropriate golf attire (collared shirts). Inappropriate apparel is at the sole discretion of the golf management staff.
- Members may be asked to leave the premises, or may have their membership suspended or revoked for any of the following: physical or verbal abuse, destruction of club property, commission of lewd or unlawful activity on the grounds, violation of club policies or rules, or any conduct that interferes with the City of Elgin's right to manage the facility and preserve the integrity of BCCC.
- The course may be closed from time to time, due to weather, maintenance issues or other events.
- **No refunds or partial refunds will be considered for breaking any of these policies or rules.**

MEMBERSHIP BENEFITS AND RESTRICTIONS

Individual and Unlimited Spouse Member Benefits

- Unlimited golf and cart at Bowes Creek, The Highlands and Wing Park golf courses
- Unlimited Practice Facility use at Bowes Creek and The Highlands
- Member Guest Discounted Rates of \$55 on weekdays and \$75 on weekends and holidays at Bowes Creek only
- NOTE: Guests must accompany members
- 20% off regularly priced retail items at Bowes Creek
- Tee Times up to 30 days in advance

Limited Spouse or Intermediate Member Benefits

- **Must be purchased with an Individual Member or Family Membership**
- Limited golf and cart at Bowes Creek, The Highlands and Wing Park golf courses
- Golf course access is not allowed with tee times before 12 noon on weekend and holidays unless a \$75 guest fee is paid
- Unlimited Practice Facility use at Bowes Creek and The Highlands
- Spouse must be living with the Individual Member
- Intermediate must be living with the Individual Member and be under 23 years of age
- No Guest Discounts

Junior Member Benefits

- **Must be purchased with an Individual Member or Family Membership**
- **No Carts are included; however, a Junior can ride complimentary with a parent member otherwise a \$12 trail fee applies**
- Limited golf at Bowes Creek, The Highlands and Wing Park golf course. Golf Course access is not allowed before 4pm on weekends and holidays unless a standard rate is paid
- Unlimited Practice Facility use at Bowes Creek and The Highlands
- Juniors must be 18 or under and living with the Individual Member
- No Guest Discounts

Family Membership

- Full benefits as described above for one Individual, Unlimited Spouse and up to four Junior Memberships
- Full benefits as described above for one Individual, Limited Spouse, Intermediate and up to two Junior Memberships

Family Couples Membership

- Full benefits as described above for two Individuals with unlimited golf from the same household and up to two Junior Memberships
- Full benefits as described above for two Individuals and a Limited Spouse or Intermediate Membership
- Additional Junior Memberships \$400 each
- Proof of family/household required

Approval of an annual golf membership application is contingent upon the payment of all required fees.

Members are also required to sign the annual Golf Cart Rental Agreement.
